

- Terms of office:



# How to secure future development of Oxalis

The Open-Source alternative for PEPPOL Access Point's





### Open-source project Oxalis is the leading open-source software

- Most common users of the Oxalis software are service providers or large enterprises that see benefit of controlling messaging services in their own environment.
- One similarity between Oxalis users is that the service is connected as part of larger technical setup
- PEPPOL authorities have **strong incentive** that there are easy and affordable solutions available to the market so that they can drive their digitalization's based on PEPPOL.
- Having an open and free solution available to the market was of the reasons why the Norwegian PEPPOL Authority made Oxalis.



### Creating the open-source community



Moving towards community funded development

- The Oxalis software development work was previously funded by one single organization.
- It has always been open-source, but contributions from others was limited.
- > Today all activities are funded by either volunteer or paid work.
- > The paid work is completly financed by membership fees.
- Since the start in November 2020, we have established a working organization that is able to keep track of upcoming changes, resolve issues and be respondent to its users.
- > BUT we need to grow our community efforts so that we can harvest our combined development strengths.





### The importance of contributions

No contribution is too small

Contributing with **testing** of new code, not only improves quality, but it makes our development more efficient.

- To help **improve documentation** not only helps others in your organization it will also make it easier for others to contribute as well.
- Have you made a smart tweak for Oxalis, why not share your ideas, and lead by example for others to follow.
- If you see a question from another user that you are able to support, then <u>share your knowledge</u> and maybe that person will help you next time.
- Do you see a development initiative that is important for your organization, then <u>giving your time</u> will help speed things up.





### Memberships is our insurance

Paid development of open-source

Volunteer efforts from our users is the goal!

But development of open-source code can also be paid.

The income from membersship fees gives us the oppertunity to buy development services.

In that way you can see the membership fees as our *insurance* to secure development activities.

What could we do if we doubled our insurance?

The potential of:

- Oxalis users that are not yet members
- Growth of PEPPOL to new markets and thereby new oxalis users

Look into different models of increasing speed of development

#### Two main goals

- ➤ How to increase our insurance, meaning our membership income.
- ➢ How to increase awareness of the open source alternative and increase contribution.
